Rules for the use of Agricultural and Food International certification certificates and accreditation marks

1. 目的和适用范围

1 Purpose and scope of application

为了使获得方圆标志认证集团有限公司(以下简称 CQM) 农食国际认认证的客 户规范使用认证证书及方案标志(如 FSSC22000 标志、BRCGS 标志等)、ANAB 认可 标志,制定本规则。

These rules are formulated for the purpose of obtaining the China Quality Mark Certification Group Co., Ltd. (hereinafter referred to as CQM) Agricultural and Food International certification of customers to use the certification certificate and scheme logo (as FSSC22000 logo, BRCGS logo etc) and ANAB Accreditation Symbols.

ANAB 系美国国家标准协会的认可机构,英文为 ANSI National Accreditation Board 的缩写。

ANAB is the accredited body of the American National Standards Institute, abbreviated as ANSI National Accreditation Board.

The basic requirements of < Management System Certification Certificate and Certification Mark and Accreditation Symbols Use Rules> are applicable to this document, and the use of ANAB accreditation Symbols refers to the use requirements of CNAS accreditation mark.

4、ISO 22000 认证声明要求

4, Requirements of ISO22000 certification statement

获证组织不应在产品或者产品包装上使用 ISO 22000 认证标志。包含所有的产 品包装,既包含初级包装(盛放产品的),也包括任何外包装或二次包装。

A certification body shall not permit the use of any statement on product packaging that the client has a certified FSMS. This includes all product packaging, both primary packaging (which contains the product) and any outer or secondary packaging.

5、BRCGS 标志(徽标)使用规定

Use rules of BRCGS logo 5

BRCGS 的徽标只准在不存在免除内容的工厂使用。获得认证且无范围免 1) 除内容的公司有权在公司信笺和其他营销资料上使用 BRCGS 食品/包装材料徽标。 BRCGS 的徽标不能被用于促销贸易产品使他们构成认证范围的一部分。具体见对 应的 BRCGS 全球标准里的要求。

1) The BRCGS logo can only be used by sites that have no exclusions. Companies that achieve certification and have no exclusions from their scope are qualified to use the BRCGS food/packaging materials logo on site stationery and other marketing materials. It should be noted that the BRCGS logo cannot be used for promoting traded products even when they form part of the certificated scope. For details, please refer to the requirements in the corresponding BRCGS global standard

2) If a site is no longer certificated because of certificate expiry, withdrawal or suspension, it shall no longer use the logo or certificate claiming by the certified organization.

3) BRCGS 徽标不是一个产品认证标志,产品或产品包装上不得使用徽标或证书。获得认证的工厂如被发现滥用 BRCGS 徽标,将受到 BRCGS 投诉/查证的约束。 而且可能会面临 CQM 对其作出认证被暂停或撤销的风险。

3) The BRCGS logo is not a product certification mark and neither it nor any reference certification may be used on products or product packaging. Any certificated site found to be misusing the logo will be subject to the BRCGS complaints and referral process and may risk suspension or removal of its certification by CQM.

4) The BRCGS logo may not be used by companies that do not include all products that are manufactured, processed, packed or labelled on site within the audit scope.

2024年7月1日 第4页共5页 Symbols and Claims of Accreditation Status>, while obtained the ANAB accreditation certificate, the ANAB Symbols shall be used for the following requirements:

- 1) ANAB 认可标志应按照如下要求进行复制:
- 1) The ANAB Accreditation Symbol shall be reproduced as following:
 - 在白色或浅色的背景下显示黑色、或蓝色(PMS 286 或类似)和红色 (PMS485 或类似);
 - 大小要使标志能够清晰可辨;
 - 尺寸不能失真变形。
 - In black, blue (PMS 286 or equivalent) and red (PMS 485 or equivalent), or only in black, on a white or light-colored background, or white on a dark-colored background;
 - In a size that makes all features of the symbol clearly distinguishable; and
 - Without distortion to its dimensions.
- 2) 当使用 ANAB 认可标志,其大小不得超过认证机构的标志的大小。
- 2) When using the ANAB Accreditation Symbol in combination with any CAB logo or mark, the size of the ANAB Accreditation Symbol shall not exceed the size of the CAB's logo or mark.
- 3) 获证组织不得分开使用 ANAB 认可标识和 CQM 标志。
- The certified organization shall not use the ANAB Accreditation Symbol and CQM mark separately.
- 4) ANAB 的认可标志不得以任何方式用于产品,或以任何其他误导方式,表明

CQM 和/或 ANAB 通过认证或批准了获证组织的任何产品,工艺或服务。

4) The ANAB Accreditation Symbol shall not be used in any manner to the product, or in any other misleading manner, indicating that any product, process or service of the certified organization have been certified or approved by CQM and /or ANAB.
